1. Public Comments

No one was in attendance for comments.

2. Parks and Recreation Director's Report

Parks and Recreation Director Charry Lawson was present, and reported that Recreation Supervisor Jack Davison will be leaving his position at the Town, and she is very sad to see him go. His last day will be Wednesday 11/23/22. Ms. Lawson stated that she has been in contact with Civil Service, and there is no eligible candidates at this time, with no scheduled upcoming tests, thus she has begun advertising. The candidate must have a two year degree with experience, or a four year degree, and they must be able to take the test when it is offered.

3. <u>Schedule Public Hearing – Local Law G-2022 – Updating the Town of Onondaga Code Enforcement Program</u>

In Town Attorney Nadine Bell's absence, Attorney Stacy Marris was present. Attorney Marris stated that the need for the upcoming 12/19/22 public hearing pertaining to Code Enforcement Updates is a result of the regular updates that the state generates, the last one being about 2 years ago. Attorney Marris took the guidance from the state and compared it to what the Town of Onondaga had on the books already. Anything that was particular to the Town of Onondaga was added in to meet the state requirements. The following Notice of Public Hearing and resolution was presented:

Local Law No. G -2022

("A Local Law Updating the Code Enforcement Program In the Town of Onondaga")

<u>Councilor Wheatley</u> introduced proposed Local Law No. <u>G-2022</u> updating the Code Enforcement Program in the Town of Onondaga and made the following Resolution, which was seconded by <u>Supervisor Mahar</u>:

WHEREAS, proposed Local Law <u>G-2022</u> has been introduced and will be considered for enactment pursuant to the provisions of the Municipal Home Rule Law and Town Law; and

WHEREAS, Volume 6 N.Y.C.R.R., Section 617 of the Regulations relating to Article 8 of the New York State Environmental Conservation Law, requires that as early as possible an involved agency shall make a determination whether a given action is subject to the aforementioned law; and

WHEREAS, no other agency has the legal authority or jurisdiction to approve or directly undertake the enactment of a local law in the Town of Onondaga, such that there are no other involved agencies within the meaning of the New York State Environmental Quality Review Act (SEQR) with respect to the proposed enactment of said Local Law.

NOW, THEREFORE, BE IT

RESOLVED AND DETERMINED that there are no other involved agencies, the Town Board shall act as lead agency, and that the enactment of this proposed local law is a Type II action under SEQR, thus concluding the environmental review process; and be it further

RESOLVED AND DETERMINED that the Town Board conduct a public hearing as to the enactment of proposed Local Law <u>G-2022</u> at the Town of Onondaga Town Hall located at 5020 Ball Road, Syracuse, New York on December 19, 2022 at 5:30 p.m., or as soon thereafter as the matter can be heard, at which time all persons interested in the subject shall be heard; and it is further

RESOLVED AND DETERMINED that notice of said public hearing shall be provided at least five (5) days prior to the date of said public hearing in a newspaper of general circulation within the Town of Onondaga and to any affected municipalities described above.

4. Engineer's Report

Town Engineer Bill Perrine was present and reported that there is concern about running out of time to pave two active subdivisions – Brittany Hills Sec. 13 & 14, and Cedarvale Ridge Section E, Phase B. Mr. Perrine stated that they need to have turnarounds in before the winter, and they hope to have it done by early December. Councilor Wheatley asked if salt had been put down on the roads yet, and Mr. Perrine stated that no it has not, as it is not paved yet. It will be just binder course pavement for the winter.

Mr. Perrine is expecting a final release of Crown Point Ext. 2, and is hoping to have that for the December 5th meeting, and asked about CHIPS funding to get the road dedications in. Councilor Wheatley replied that it will have to wait until next year, as the deadline to apply is usually early November.

Mr. Perrine also reported that the next round of Bridge NY Funding has come out, which is due in mid January. NYS requires that a solicitation process is required to seek interest from other consultants to prepare these applications and future design/construction administration on behalf of the Town. The Town completed this process in 2021 and the NYSDOT has recently confirmed that this solicitation process if good for three years. He is working with John Smith and Linda Crowley to get those resubmitted for this year, in which C & S Engineers, Inc. will complete the Bridge NY application at no cost on the Town's behalf. The four projects that will be targeted are: Lawndale Drive, Broad Road (by Skyline), Broad Road (by Hopper Brook/SOS), all culverts; and Braeburn Drive in Nedrow, a bridge replacement. If time allows, the existing culvert at Ironside Drive in South Onondaga will be added as well. It will be an application update, as these are the same ones that were applied for last year. Mr. Perrine stated that it's not uncommon to get denied several times in a row, but encourages the Town to keep applying.

5. Committee Reports

Fire and Safety Committee member Lisa Goodwin was present and reported that on Sunday 11/20/22, members of the Board went to the Howlett Hill Fire Dept. and celebrated Denice Bealer's 50 years of service with the Ladies Auxiliary. The following proclamation was presented to her:
